Woodbridge Senior High School - Mighty Viking Marching Band Trip to Disney in Orlando, FL - November 4, 5, 6 and 7, 2010

The Woodbridge Senior High School Marching Band and Guard have been invited to march in a Disney Parade and will be flying to sunny Orlando, Florida. In order for the planning team to make the necessary flight arrangements and reservations for our lodging, the boosters are requiring a commitment form and plane ticket deposit from each and every student who will be attending no later than **August 25, 2010**.

The attached commitment form and your **non-refundable deposit** (a portion of the airfare) of \$125.00 will assure your student a spot on this trip. The \$125.00 deposit will be applied towards the total cost of the plane ticket (total cost for the plane ticket is \$277.15). The booster organization *will pay for the plane tickets in full* as soon as we have your commitment form and airfare deposit. Should you decide your student will not be attending this trip after the non-refundable deposit payment is paid, **you will still be responsible for the remaining cost of the plane ticket** in order to reimburse the booster organization.

A full itinerary for the trip will follow in the next few weeks or sooner. The total cost (including airfare) is \$600.00 per student and includes all transportation, 4 days Park-Hopper pass to several Disney parks, three nights lodging, and 11 meals (3 breakfasts, 4 lunches and 4 dinners). As stated above, your deposit of \$125.00 is due no later than Wednesday, August 25, 2010, and the remaining payments have been set in four equal payments of \$118.75 due on September 1, September 15, October 1, and October 15, 2010 (final payment). ***If you pay the full amount by September 15, you will save 5% on the total cost of the trip; bringing your trip cost to \$570.00!! This means if you pay your \$125.00 deposit on August 25, 2010, you only need to pay \$445.00 by September 15, 2010.***

Should you choose to withdrawal your student from the trip, you must notify the boosters and the planning team **in writing** (a letter, including the date, student name, and reason for withdrawal, placed in an envelope marked "Disney Trip Withdrawal" put in the silver box in Mr. Carder's office) by September 15, 2010. If notification of the withdrawal is not received in writing by this date, you will be responsible for the entire cost of the trip (full \$600.00). You must understand once the commitment form and deposit is received, the boosters will pay all fees in full as it is a requirement of Disney that all fees are paid to them 45 days prior to our departure. As always, a payment contract can be put into place if needed (see booster president, Tami Cope-Jones; treasurer, Shauna Schwartz; or Mr. Carder), and we will also accept payment via Pay Pal on the band's web page (www.woodbridgeband.org).

If your student is unable to attend, please fill out the commitment form in the appropriate section and specify the reason(s) why he/she is unable to participate. Currently, we are **ONLY** accepting commitment forms from the **students**. After the number of attending students is finalized, there will be requests made for chaperones. If space allows, we will then post availability for "tag-a-longs" for those who wish to accompany the band on this trip but without the responsibilities of being a chaperone.
